## Introduction

All applications, which would like to overtake the certification process of Tic Salut Social Foundation, must pass all the criteria of that process, which establishes a safe and trustful environment for this technological use. During the accreditation process, the App shall pass a series of criteria organized in four blocks: Usability, technology, security and contents.

At the end of the assessment process, the mHealth Office will grant a numerical mark resulting from the evaluation criteria of those Apps which have successfully overtaken the minimum compulsory requirements.

## Labels and mark calculation

Each one of the Apps that pass that process will have a numerical score related to the result of having **OVERCOME** the assessment process. This score is calculate by the sum of partial marks of each block; each block will have a weight equivalent to the 25% of the total score.

The minimum requirements or compulsory compliance for getting the certification label is to overcome the conditions where the label is **COMPULSORY**. Otherwise, the App will not get the certification label. To obtain the mHealth certification the App has to overcome **ALL** mandatory requirements for each block.

Once overcome the minimum level, the final mark is calculated by adding all the achieved criteria applying a weighting factor for the required standards of 0.5 for mandatory criteria, 0.35 recommended and 0.15 desirable criteria, divided by the total amount of block criteria with its corresponding weighting, as it is shown in the following formula<sup>1</sup>:

$$\text{Mark of block} = \frac{\sum_1^n (CO * 0,5) + \sum_1^n (RO * 0,35) + \sum_1^n (DO * 0,15)}{\sum_1^n (TC * 0,5) + (TR * 0,35) + (TD * 0,15)}$$

### Random audits
